

NOMINATIONS FOR THE 200TH ANNUAL CONVENTION OF THE DIOCESE OF MAINE

Nominations opened in May of 2019 and the deadline for inclusion in the Convention Folder was September 9, 2019. Nomination may be by one individual or one body. Only one nomination per person per office is accepted. The first nomination received is distributed to the diocese.

Below, following the description of the office is a list of those currently holding the position.

- An asterisk (*) indicates the person is eligible for re-election.
- A plus sign (+) indicates the person is not eligible for re-election because of term limits.
- A minus sign (-) indicates the person is not eligible for re-election because of no longer being canonically resident OR a change in status (i.e. previously lay and now clergy).

SECRETARY OF THE DIOCESE

CANON 6, DIOCESE OF MAINE (Of the Secretary of the Diocese)

Section 1. Unless otherwise directed by the Convention, the Secretary shall give written notice of the time and place of the meeting of a Convention by mailing a copy of such notice to each Clerical Member of the Convention and to the Clerk of every Parish or Mission in union with the Convention together with the certificates for Lay Delegates. The notice of any Special Convention shall specify the purpose thereof.

Section 2. It shall be the duty of the Secretary to mail a copy in blank form of the Parochial Report to every incumbent of a Parish or Mission, which shall be duly filled in and returned before the first day of the month specified. The Secretary shall, with whatever assistance the Secretary deems necessary, examine all Parochial Reports and return for correction those in which errors or omissions appear. He shall compile, file, and keep on record the statistics from the Parochial Reports for presentation to the Annual Convention following the year for which such reports were made. A complete tabulation of all Parochial Reports shall be printed in the Journal.

Section 3. It shall be the duty of the Secretary to prepare for presentation to each Diocesan Convention a report on the actions taken on each of the resolutions adopted by the previous Diocesan Convention.

Section 4. In case of the disability of the Secretary of the Diocese, the duties shall devolve upon one of the Assistant Secretaries, if there be such, in order of their appointment; if not, upon the Secretary of the Standing Committee.

NEED TO ELECT: One person for a one year term.

Responsibilities: The position of Secretary of the Diocese requires familiarity with the process of the Convention. In addition to the canonical responsibilities, the Secretary oversees the registration of delegates to convention and monitors the balloting and election process during Convention. Serves as Secretary of Diocesan Council requiring attendance at Council meetings (two Saturdays and two Friday evening/Saturday overnights) during the year. Significant support is provided by the diocesan staff to fulfill canonical requirements.

Time Commitment: 5 days per year

Expenses: Travel, room and meals at Diocesan Convention and Diocesan Council meetings, reimbursed by diocese if requested.

Skills: Leigh has an intimate knowledge of the duties and skills required for this position. She is an excellent typist and has outstanding interpersonal skills.

TREASURER OF THE DIOCESE

CANON 7, DIOCESE OF MAINE (Of the Treasurer of the Diocese)

Section 1. It shall be the duty of the Treasurer to receive and disburse all moneys collected under the authority of the Convention, unless the collections and disbursements shall be otherwise specifically ordered. The Treasurer shall render a report to the Annual Convention which shall contain a certificate that his accounts have been audited by Diocesan Auditors. The Treasurer shall render a report to the Annual Convention which shall contain a certificate that these accounts have been audited in accordance with Canon 18.1.5.

Section 2. The Treasurer may be removed from office by the Bishop, with the consent of the Standing Committee, for any neglect, misconduct, or incapacity.

NEED TO ELECT: One person for a one year term.

Responsibilities: The position of Treasurer of the Diocese requires familiarity with accepted accounting procedures and policies and with diocesan financial operations. The Treasurer oversees accounting procedures, cash flow, expenditures in line with current budget and anticipated income. The Treasurer provides guidance and support for the diocesan financial department.

Time Commitment: Approximately 8 days per year.

Expenses: Travel expenses reimbursed by diocese if requested.

Nominee for Treasurer: Mr. Richard Rozene, St. Ann's, Windham

Nominated by: Vestry of St. Ann's, Windham



Biography: Dick currently serves as diocesan treasurer and has served the diocese in the position since 2011. In this capacity, he monitors the income and expenses of the diocese. He would welcome the opportunity to work with Bishop Brown during the first year of his episcopate.

As treasurer, Dick has a working relationship with the Bishop and Finance Chairperson as well as the Canon for Finance and Stewardship, key elements for serving as treasurer. Dick is a member of Diocesan Council (by Canon), the diocesan Finance Committee, and the Strategic Mission Support committee. He works with the other staff of the diocese and congregations pertaining to budgeting and other financial matters. Dick is also a member of the diocesan

Compensation Committee, which has been working to develop a fair compensation package for clergy as it has done for the Bishop and lay employees. Dick has been the lay representative to Provincial Synod and was a deputy to General Convention in 2015 and 2018. Past diocesan and local congregation experience include terms on diocesan council; chair of a commission responsible for a former grants-in-aid program; a member of the Strategic Mission Study group convened by Bishop Lane; an Episcopal discernment committee; vestry, parish discernment committee, long-range planning, and senior warden at St. Ann's.

Dick understands budgeting and financial accountability due in part to his career in private industry as a project and program manager. In those capacities, he managed multi-million dollar projects which often had demanding time lines. He believes his past experience as diocesan treasurer, interaction with key diocesan staff, clergy and lay persons in the diocese over several years will provide Bishop Brown with support in this first year of his episcopate. Finally, Dick believes that the diocese must continue to practice good stewardship within the framework of our available financial resources it seeks to do God's work in the world around us.

THE STANDING COMMITTEE

CANON 13, DIOCESE OF MAINE (Of the Standing Committee)

Section 1. The Standing Committee shall at its first meeting choose a Chair and a Secretary, either Clerical or Lay. The Secretary shall record all proceedings in a book provided for the purpose, and this, with all papers relative to the business of the Diocese, shall be open to examination by the Bishop and by the Convention; and a report of the acts shall be made to the Annual Convention, except such acts as pertain to its function as a Council of Advice to the Bishop.

Section 2. A majority of the Committee shall constitute a quorum.

THE STANDING COMMITTEE (CONT.)

Section 3. The Standing Committee shall be a Council of Advice to the Bishop, and shall be summoned at any time that the Bishop may desire its advice.

Section 4. The Standing Committee shall be the Ecclesiastical Authority of the Diocese when a vacancy occurs in the Episcopate, except in cases otherwise provided for by the Canons of the General Convention or of the Diocese.

NEED TO ELECT: One clerical and one lay member for a three year term each.

Responsibilities: The Standing Committee serves as the Ecclesiastical Authority of the Diocese when a vacancy occurs in the Episcopate (except in cases otherwise provided for by the Canons of the General Convention or of the Diocese). Other responsibilities include serving as Council of Advice to the Bishop, consenting for election of bishops in ECUSA, reviewing and approving building plans and loans by congregations, as well as interviewing and recommending people in the ordination process.

Time Commitment: The Standing Committee meets monthly, usually in Portland. Special meetings may be called.

Expenses: Travel expenses reimbursed by diocese if requested.

Clerical Nominee for Standing Committee: The Rev. Claudia Wyatt Smith, retired

Nominated by: The Rev. Nancy Moore



Biography: The Rev. Claudia Wyatt Smith was a late vocation having held a number of executive positions in the healthcare field prior to answering God's call to ordained ministry. She received her MDiv from the School of Theology at the University of the South in Sewanee, TN in 2005 and upon her ordination, immediately accepted the position of Vicar of St. Benedict's in a small mountain town in Colorado. In 2007 Claudia moved her canonical residency to Maine when she accepted the call to become the 3rd Rector of St. Francis by the Sea in Blue Hill. During her nearly 12-year tenure at St. Francis she guided them to revision their ministry and saw them through a successful capital campaign. Additionally she led them to put on four nationally attended Downeast Spiritual Life Conferences, bringing such well-known speakers as Richard Rohr, Phyllis Tickle and John Philip Newell, to Maine.

At the Diocesan level, Claudia served 2 years as Chair of the Commission on Congregational Life, 2 terms on the Diocesan Council (including one term as co-chair with Bishop Steve), chaired a task force charged with exploring options for streamlining the Diocesan Convention and most recently served on the Discernment Committee for the Bishop search process. Claudia retired in March 2019 and now resides in South Portland. This enables her to be more available (in both time as well as geographic location) to engage in the work of the diocese especially, putting to use, her depth of experience of both the broader work of the church as well as an intimate understanding of the area of the state surrounding the Blue Hill Peninsula.

Skills: Claudia is a deep and very present listener. She comes prepared having reflected carefully on whatever question has been placed before her, and seeks wisdom before speaking. She balances this with a light-hearted sense of humor and an ability to find joy in most circumstances. She has a sense of the long tradition of the church but is also interested in exploring ways to be a new church for a new age and is a firm believer in a shared ministry that recognizes, encourages and empowers all God's children (Lay and clergy alike) to make use of their gifts and talents.

As a leader she is able to set aside her personal agenda and focus on exploring the broader questions before the group as she tries to draw others into the decision making process. In the midst of chaos she has the ability to maintain focus while maintaining a calming countenance.

Clerical Nominee for Standing Committee: The Rev. Timothy Higgins, St. Ann's, Windham

Nominated by: Mr. Michael Dionne



Biography: Tim and Maureen Higgins live with their three children in Gorham. Maureen is employed as an Oncology Social Worker by the Dempsey Ctr. for Cancer, Hope and Healing in Lewiston/So, Portland. Maeghan is a senior at Syracuse University. Garrett is a sophomore at UVM and Maeve is a senior at Gorham High School. Tim has served as rector at St. Ann's for twelve years. Tim has held multiple leadership positions in the local community as chair of the Windham Area Clergy Association, chair of My Place Teen Center and a board member for Be The Influence (local community leaders working to keep kids of drugs). While serving at St. Ann's, Tim has initiated a prison ministry at MCC, local evangelism teams, as well as a very active pastoral care team. Tim has a knack for relating well to veteran members of the community as well as the churches youth. At the Diocesan level Tim has served two terms on Diocesan Council, Chair of the Mission Priorities Committee and presently on the Standing Committee as the liaison for the Commission on Ministry.

Skills: As Tim finishes his first term on the Standing Committee, he looks forward to using that experience for another three year term. Tim would bring the same passion, energy, love of the Church and dedication to another term. Tim sees the future of the Diocese being immersed in regionalization and would bring his "huge heart" and commitment to pastoral care to these conversations. Tim and another clergy person in Maine have developed the Maine Evangelism Network and it is his call to ongoing evangelism that will serve the Standing Committee very well. Tim is the consummate team player and seeks consensus when decisions need to be made. He would use this skill set to continue to serve the Standing Committee in the Diocese of Maine.

Lay Nominee for Standing Committee: Ms Patricia Ryan, St. Paul's, Brunswick

Nominated by: The Rev. Carolyn Eklund



Biography: Pat Ryan retired in 2011 as Executive Director of the Maine Human Rights Commission, after serving for 32 years. She currently conducts mediation for the Commission in cases filed with it.

She has been active at St. Paul's, Brunswick, serving as Senior Warden, Junior Warden, Vestry member, and currently chairs the Outreach ministry. She recently co-chaired a successful Capital Campaign, raising monies for interior and exterior work on the entire building. Pat has represented St. Paul's as a delegate at diocesan conventions over the last six years. She was elected as a lay member of the Diocesan Disciplinary Board in 2015, and served a 3-year term.

Currently, Pat serves on the Board of The Gathering Place, and serves as a volunteer. The Gathering Place was founded in 2010 in Brunswick to give daytime shelter, friendship and hope to the materially poor and homeless. Pat was a founder of the Maine Women's Lobby, the oldest organization in the country lobbying on behalf of girls and women, and recently completed a 6-year term on the Board of Directors.

She lives in Brunswick with her husband, Charlie Priest.

Skills: Pat was serving as Junior Warden at St. Paul's when the Vestry called me to be the rector in 2013. She then was elected to be Senior Warden. We worked closely, meeting each week with the Junior Warden as we collaborated and guided the parish to achieve the goals presented in the Parish Profile. She was a wise, discerning presence then, and is now as I often continue to seek her counsel to help me discern matters of the parish. She has served on the Finance Committee at St. Paul's since I've been Rector, and last year co-chaired the fund-raising committee for our successful Capital Campaign. After that program concluded, Pat agreed to serve on the Clergy Renewal sabbatical grant-writing committee and assisted in the planning for the parish activities for the theme, "Deepening our Practice of Christian Hospitality."

As a mediator for the Maine Human Rights Commission, Pat has had a breadth of experience negotiating and giving counsel to ensure just outcomes. Her passion for Outreach has led our parish into generous giving to local, state and national non-profit organizations. She assisted in writing two successful New Initiative grants from the Diocese of Maine; one for raising diocesan awareness of addiction and one for a Greater Brunswick Community conversation on our local problem of teen homelessness.

Biography: I entered The Episcopal Church during my senior year in college in Virginia. Since that time, I hope I have grown in faith and in service. Inasmuch as I am married to an Episcopal priest, serving in parish leadership roles have not always been available to me. When that has not been a barrier, I have served on vestries three times in two dioceses, as Senior and Junior Warden during times of parish transitions, as Delegate of Diocesan Convention, and on the Committee on Holy Orders/Commission on Ministry (2003 - 2009). As a Warden on Mount Desert Island, I have been part of a multi-year effort among the four Parishes here to work more closely together.

For almost twenty years, I have practiced law in Eastern Maine and that has introduced me to a wide range of clients with a broad range of legal challenges and the economic and demographic changes in our state.

I am very hopeful for our Diocesan future, as all members of the Diocesan consider what is an authentic treasure that should be cherished, what historical burdens we might leave behind, and what changes we should celebrate and incorporate in our common life together.

GENERAL CONVENTION DEPUTIES AND ALTERNATES

CANON 11, DIOCESE OF MAINE (Of Deputies to the General Convention)

Section 1. At the Annual Convention in the twelve months preceding the date which is twelve months prior to the opening date of the next General Convention, four Clerical and four Lay Deputies and four Clerical and four Lay Provisional Deputies shall be elected to represent the Diocese in the General Convention. Vacancies in the office of Deputies shall be filled by the Ecclesiastical Authority from among the Provisional Deputies. A vacancy shall exist if a Presbyter having been elected a Deputy shall cease to be regularly engaged in the active ministry as described in Article III 3(1) of the Constitution of the Diocese of Maine.

Section 2. All elections provided by this Canon shall be by ballot unless otherwise agreed by unanimous consent. Responsibilities: Represent the Diocese of Maine at the 80th General Convention of the Episcopal Church where policy for the Episcopal Church is set. Approve the Episcopal Church triennial budget; Fill seats on the Provincial Synod if the Annual Convention does not elect either or both of the deputies or alternate deputies in any year (Canon 12, DIOCESE OF MAINE, Section 2.)

Time Commitment: Some pre- and post-convention meetings held within the diocese and New England and attendance at the General Convention June 30 to July 9, 2021 in Baltimore, MD and attendance at Provincial Synod meetings if called to fill a vacancy

Cost: Convention expenses paid for clerical and lay deputies by the diocese.

Clerical Nominee for General Convention: The Rev. Nathan Ferrell, Saint Mary's, Falmouth
Nominated by: Mr. Leonard A. Taylor, Jr.

Claudia steadfastly led the congregation to address the distressed state of our facilities that at the time of her arrival were plagued with years of water leakage and mold issues, resulting in a successful two-tiered capital campaign, and the beautiful renovation of our facilities both structurally and aesthetically. Through Claudia's faithful wisdom the congregation of St. Francis enjoyed new life as a result of her continual recognition and encouragement of our skills and talents, always recognizing the power and importance of the laity.

Most importantly, Claudia enlivened the Gospel of Jesus Christ at St. Francis, throughout the Blue Hill Peninsula, and in the Diocese of Maine through her outstanding skills in liturgical practice and homiletics, her passion for education (notably the well-attended Wednesday Seekers and Down East Spiritual Life Conferences), and her foundational belief in love, inclusion and justice; ever reminding us to respect the dignity of every human being and to enthusiastically embrace and embody the words of our Sabbath benediction: "...be swift to love. Make haste to be kind."

During Claudia's years as Rector of St. Francis, we enjoyed record membership, record annual pledging and gifts, and record contributions to our ministry partners through Outreach. She has been a model leader and faithful servant, sharing our joys and sorrows, and extending the love of Christ to all.

Clerical Nominee for General Convention: The Rev. Dr. Nina Pooley, St. Bartholomew's, Yarmouth

Nominated by: Ms. Harriet Davis



Biography: Nina Pooley is the rector of St. Bartholomew's Episcopal Church in Yarmouth, where she has served for twelve years. During her time at St. Bart's, the parish has managed a successful capital campaign and completed major renovations in September 2012. Following the expansion of the education wing, the parish hired the first paid Education coordinator and developed a lectionary-based curriculum for use by parishes in the Diocese, with much direction and guidance from Nina. Nina's focus at St. Bart's has been on intentional liturgy, full participation of the parish, the growth and well-being of children's ministries and family worship, and the ways the parish serves the community. Under Nina's tenure, St Bart's is attracting increasing numbers of new members from un-churched backgrounds. Nina's ministry is focused on formation of disciples through intentional liturgy, teaching, preaching, and outreach ministry across the generations. Currently St. Bart's is one of three churches in Yarmouth working in collaboration to provide emergency and permanent housing to refugees and asylum seekers. The model we have developed in Yarmouth is now being shared with other surrounding communities.

Nina's work in the diocese includes serving on the Clergy Day Committee, and on Bishop Lane's Mission Priorities Study Group subcommittee; though she has been primarily involved in Diocesan Finance. Serving on the Finance committee for 11 years, as Chair for 3, and in that role, as Chair of the Strategic Mission Support subcommittee, and a member of Diocesan Council's Executive Committee.

Nina's experience with the Wider Church includes serving as a Deputy for General Convention in 2015 and 2018, and now as Vice Chair for the Task Force for Liturgy and Prayer Book Revision, an interim body of General Convention. In 2015, as a member of the Maine deputation, Nina was selected to be on Legislative Committee 16: Environmental Stewardship, Care of Creation. While on that committee, she served as co-chair of the subcommittee for resolution A030. That subcommittee recrafted resolution A030 from a call for a study group to a grant program funding on the ground research through grants for regionally appropriate responses to environmental need. The resolution passed both houses and was funded by Program, Budget and Finance for the Triennium of 2015-2018 at more than \$600,000 in funding available for green grants. Together with the Maine deputation, Nina co-authored with Calvin Sanborn

Resolution D050 Authorizing "An Order for Celebrating the Holy Eucharist at a Principal Service" which passed both houses and provides tools for evangelism and outreach beyond the traditional parish setting. Being bi-racial (Nina's father was born and raised in India); she was invited to participate as a member of the Deputies of Color Caucus meetings at GC78. In preparation for General Convention in 2018, Nina participated in the Deputies of Color Caucus gathering in Austin, and is now an active member of this group of Deputies. It is a rare opportunity for a member of the deputation from Maine to be included in the deputies of color caucus, and Nina is pleased to be able to represent us in that context. At General Convention 2018 Nina served on Legislative Committee 16: Church wide Leadership, where she was asked to serve as the Chaplain for the committee. This committee heard resolutions from the Task Force for the Episcopacy, the proposal to fund the President of the House of Deputies, and resolutions about the reshaping of the College for Bishops, among other legislation. As Vice Chair of the Task Force for Liturgy and Prayer Book Revision, Nina will lead the presentation of this body's report to the House of Deputies at General Convention 80, in 2021.

Nina completed her Doctor of Ministry degree while at St Bart's, with a focus on Liturgy and the Church in the 21st Century, through The School of Theology in Sewanee, Tennessee. Before coming to St. Bart's, Nina was the associate Chaplain at St. Paul's School for Boys in Lutherville, Maryland. Prior to that she was the Associate Rector at Church of the Good Shepherd, Lookout Mountain, Tennessee.

Skills: Nina has a deep appreciation for the various perspectives around the diocese about life and ministry in different areas and contexts. She is passionate about the work small churches are doing in their communities and has worked hard on finance and council to make sure that those efforts are both valued and supported whenever possible. She


has worked to make the diocesan grant structures fair and clear in their expectations, and to communicate issues of finance and budget in ways that people can understand them.

Biography: Dean Shambaugh is an Episcopal priest whose ministry has included living in and around New York, Chicago, Washington, DC, Paris, Barbados, and the National Parks, doing development work in Africa, Haiti, and an Indian Reservation in the American West, and leading study tours to the Holy Land. Ordained in 1988, he has served four congregations and has had a wide variety of mission experiences including time as a chaplain at the National Cathedral in Washington, as Canon Pastor to the American Cathedral in Paris, France and his current position as Dean of St. Luke's Cathedral in Portland, Maine. In Portland he has served on the boards of Preble Street, the Religious Coalition Against Discrimination, and St. Elizabeth's Essentials Pantry and was active in campaigns for marriage equality and for health care reform. In 2013 he was named Preble Street's Board Member of the Year and received Integrity Maine's Founders Award for his work opening marriage to all people. As adjunct faculty member of Bangor Seminary, he taught courses in Liturgy, Mission, and the future of the church. He has served as faculty for the Episcopal preaching foundation, teaching preaching to military chaplains and is currently an applicant for in the ACS chaplaincy program of the Coast Guard Auxiliary. In 2015, he

received a commendation by the mayor and city council of Portland for his work in the city. He has served as a member and President of the Standing Committee, an alternate, member, and chair of the General Convention Deputation and worked closely with the North American Cathedral Deans as well as many other committees and groups. He has a BA (with honors) in psychology from Northwestern University, an M.Div. from the General Theological Seminary, and a D.Min. from Seabury Western Seminary. He is married and has two grown children. In his free time, he enjoys hiking, kayaking, playing his tuba in the Maine Pops Community Band.



Biography: Originally from Maine, Aaron grew up in Ogunquit with his family and attended local schools before going off to college to earn a degree in Architecture from Roger Williams College. Aaron is not a cradle Episcopalian but came to the Episcopal Church in 1993 and was baptized in preparation for marriage. Aaron became involved in St. George's Church in York Harbor where he and his wife Cindy were married, first as a parishioner and then as part of the vestry. The rector at the time at St. George's, Paige Blair, urged Aaron to join a formal discernment group after they had several conversations about the Diaconate. Aaron discerned a call to ordained ministry and was admitted as a postulant in 2003 and entered formation. He was ordained Deacon in 2006, and has been serving at St. George's York Harbor and Trinity Summer Chapel, York Harbor ever since.

Aaron's primary ministry for his first seven years as Deacon was as a Chaplain at the Maine Correctional Center in Windham, working with incarcerated men and women as well as providing support and guidance for the Correctional Center staff. In 2015, Bishop Steven Lane asked Aaron to serve as Archdeacon to assist those in formation as Deacons, to help facilitate communication and support to the Deacons in the Diocese and to work with the Commission on Ministry on the Diocesan discernment process. Aaron, his wife Cindy, and their seventeen year old son Timothy live in York.

Skills: Aaron has a good working knowledge of church governance at the Parish, Diocesan, Provincial and Church-wide level. Aaron served as the Parish treasurer at St. George's York Harbor prior to ordination and as a Deacon in the Diocese for the past 13 years. As Archdeacon, he works with the Bishop and Diocesan leadership on issues of Deacon Formation and deployment as well as the Commission on Ministry on issues of discernment. I have served as Rector in Camden for just over two years. It's good to finally be home.

I currently serve on the Commission on Ministry (COM) and I am an advocate for poor and marginalized communities both within Maine and nationally. Biography: The Rev. Maria J. Hoecker is Rector of St. Columba's Episcopal Church in Boothbay Harbor since 2012. A native of Kansas, Rev. Hoecker received her M.Div. from the School of Theology at the University of the South in Sewanee, TN in 2005. While in seminary, she was the director of Christian Education at the university parish church and guest editor for two issues of The Sewanee Theological Review. Upon graduation from seminary, she served for five years as Associate Rector of St. Philip's Episcopal Church in Brevard NC and served on the diocesan council of Western North Carolina. For two years, Rev. Hoecker studied adaptive challenge leadership with a cohort of Episcopal clergy from around the country in the Clergy Leadership Project sponsored by Trinity, Wall Street. Biography: After completing his Master of Divinity at Episcopal Divinity School in 2002, Calvin was ordained a priest right here in Maine. With the support of the Diocesan Clergy Intern Program, he served as Assistant Rector for two years at St. George's in York Harbor. When the internship ended in 2004, he moved to New York City where he attended the General Theological Seminary, working toward a Master of Sacred Theology in Christian Spirituality, while serving as the Chaplain to Episcopal students at New York University. As much as he loved his ministry in New York City, however, he missed Maine. It was with great joy that he and his husband, Dan, returned in 2005, after he accepted a call to be the Rector of St. Matthew's in Hallowell, where he served for 5 years. Calvin served as the rector of St. George's Church in York Harbor from December 2010 to November 2018. He is currently the primary care-giver of his four young children, but remains very active in diocesan life. He serves on the Board of Directors for Time of Wonder Early Learning Center, founded by St. George's in York during his tenure as rector. Time of Wonder provides high quality, affordable early education and child care for working families. His

Biography: I grew up in New Jersey and have lived in Maine for the last 25 years. I grew up in the Episcopalian church. I served as a Sunday School teacher and coordinator at St. Ann's, Windham and was a delegate to Diocesan Convention for 2 years. I completed Education for Ministry, a Diocesan-wide discernment group for laypersons and a course in teaching the Bible. In 2004 I got a Master of Arts in Theological Studies at Episcopal Divinity School in Cambridge, MA. I have been a member of the Cathedral of St. Luke for about 5 years, and am very active in St. Luke's Public Policy and Environmental Action Team. DISCIPLINARY BOARD

CANON 27 DIOCESE OF MAINE (Of Misconduct by a Priest or Deacon)
Section 1. Disciplinary Structure. The Disciplinary Board provided for in an Agreement shall be a court for the Diocese for the discipline of Priests and Deacons of the Diocese. Members of that Board from the Diocese shall meet the eligibility requirements and be selected as provided in Part B, Sections 2(2)-2(4) below, except that the number of members shall be as provided in the Agreement and their terms shall be staggered so that as nearly as is practicable one-third of the members shall be elected each year.

In the fall of 2010 the dioceses of Maine, New Hampshire, and Vermont each approved a Multi-Diocese Agreement to form a joint disciplinary board of six priests or deacons and five lay people to address matters of clergy discipline. Canon 27 and the Multi-Diocese Agreement may be found on the diocesan website at www.tinyurl.com/mainecc.

NEED TO ELECT: One lay member for a three (3) year term.

Responsibilities: In the event of a charge of clergy misconduct, members of Disciplinary Board must meet to review the matter in accordance with the Multi-Diocese Agreement and the requirements of Canon 27. If the Disciplinary Board is called upon to consider a disciplinary matter, extended meetings are a possibility.

Time Commitment: As needed until the matter is resolved.

Expenses: Travel expenses reimbursed by the diocese if requested.

PROVINCIAL SYNOD

CANON 12, DIOCESE OF MAINE (Of Deputies to the Provincial Synod)

Section 1. Every two years, one clerical deputy and one lay alternate deputy to the Provincial Synod, may be elected by the Annual Convention for a term of two years; and in the intervening years, one lay deputy and one clerical alternate deputy to the Provincial Synod may be elected for a term of two years.

Section 2. If the Annual Convention does not elect either or both of the deputies or alternate deputies in any year as provided in Section 1, or if any deputy office becomes vacant during the term thereof, the persons serving from time to time as First Clerical Deputy, Second Clerical Deputy, First Lay Deputy and Second Lay Deputy to the House of Deputies of the General Convention of The Episcopal Church from the Diocese of Maine shall serve ex officio in the vacant office as the Clerical Deputy, Alternate Clerical Deputy, Lay Deputy and Alternate Lay Deputy, respectively, to the Provincial Synod from the Diocese of Maine.

NEED TO ELECT: One clerical deputy for a two year term and one lay alternate for a two year term

Responsibilities: Deputies to Provincial Synod serve as representatives of the Diocese of Maine to the Province of New England (Province 1). Responsibilities include review of various provincial programs and policies and approval of the provincial budget.

Time Commitment: Attendance at one or two provincial meetings per year.

Expenses: Travel expenses reimbursed by diocese if requested.

DIOCESAN COUNCIL

CANON 15, Diocese of Maine (Of the Diocesan Council)

(1) The congregations and the clergy of the Diocese shall be grouped in Areas in such number and manner as the Bishop and Diocesan Council, in consultation with the clergy and congregations, shall from time to time determine.

(2) There shall be a Diocesan Council composed of the following members:

The Bishop(s); Two members, one lay and one clergy, representing each of the Areas of the Diocese;

The Chairperson of the Finance Committee; the Treasurer of the Diocese; and no more than four members appointed by the Bishop.

(3) Selection of members shall be as follows:

a. In addition to the Bishop Diocesan of Maine, if there be any Bishop Coadjutor or Bishop(s) Suffragan, whose duties include service on the Council, each such bishop shall likewise be a member.

b. Each Area shall elect two members to serve staggered terms of two years. Each member shall be elected in accordance with procedures established or approved by the Council, either from the clergy of the Area, as eligible under Article III.3.1 of the Constitution of the Diocese of Maine, or from the lay members, who are communicants in good standing of their respective congregations within the Area. The names of those elected shall be communicated to the Bishop for review, and presented at Convention.

c. The Bishop may appoint not more than four members to the Diocesan Council at any time the Bishop may deem convenient, to serve until the final adjournment of the second Diocesan Convention held after their appointment. If there be no Bishop, the Standing Committee shall have the power of appointment.

DIOCESAN COUNCIL (CONT.)

- (4) No person having served as a member of the Diocesan Council for six consecutive years shall be elected or appointed to the Diocesan Council until after the expiration of one year following the sixth year of service. For the purpose of this Canon, the period between annual Diocesan Conventions shall be deemed one year.
- (5) Vacancies in the number of members of the Diocesan Council elected by an Area may be filled by the Area or by Diocesan Council. The appointing authority may fill vacancies in the number of appointed members of the Diocesan Council. In all cases such elections or appointments shall be for unexpired terms only.
- (6) The Bishop or the Convener appointed by the Bishop shall preside at all meetings of the Diocesan Council. In the absence of both, the Council shall have the power to choose its own presiding officer.
- (7) The Diocesan Council shall administer and carry out the work of the Episcopal Church within the Diocese of Maine, subject to such directions as the Diocesan Convention may give. Within 30 days of adjournment of the annual Diocesan Convention, Diocesan Council shall schedule and publish the dates of Council meetings for the ensuing twelve months; Diocesan Council shall, in advance of such scheduled meetings, make the proposed agenda available to the members of the Diocesan Council and to the Areas.
- (8) At least six weeks before the date set for the Annual Diocesan Convention, the Council shall prepare an estimate of the amount of money required for the work of the Diocese during the next ensuing year -- that is, from January 1 to December 31. The Council shall determine and recommend to Convention the assessments required to carry out the ministry of the Diocese.
- (9) The Diocesan Council shall establish a Finance Committee.
- (10) In addition to establishing a Finance Committee, the Diocesan Council may establish such other commissions, committees, and task forces as it may deem advisable.
