It would be a privilege to continue to serve as one of the diocesan clergy representatives to the Disciplinary Board. The task of the board is a sacred one. It strives to uphold the integrity of our Baptismal Covenant by having clearly stated expectations of appropriate behavior and a fair and thorough process to review complaints of priest or deacon misconduct while also partnering with diocesan leadership to ensure support is provided to all parties involved. Recent participation in a review demonstrated the compassionate and professional thoroughness of the process.

I've been actively involved/responsible for oversight of disciplinary practices, especially while working in higher education. As associate dean of students at the University of New England, I co-led the yearly oversight of the student handbook's judicial policies and procedures, working with university attorneys to ensure rights of those in the process were honored and procedural guidelines were followed.



I convened and trained undergraduate disciplinary committees and served on student, staff and faculty disciplinary committees. This experience of working with attorneys to craft and oversee a process which balances accountability and compassion was an asset to my service to date.

Additional experience includes serving as a Safe Church trainer for the diocese when it was still done in person and working with diocesan staff to create an initial template of policies and procedures for use in congregations responding to a request of a person on the sex offender registry to worship in a parish.

She helped organize the Gender Clinic at UAMS and their first Pediatric Gender Clinic.

Gwen was elected to the Standing Committee at the 204th Diocesan Convention of Maine. She is a steering committee member of TransEpiscopal. In 2022, she joined other advocates speaking to the Executive Council on life in the church as a transgender clergy person. She has served two trienniums on TEC's Interim Body to Oversee the Continuing Development of Anti-Harassment Best Practices.



Gwen also served on the Resolution Review Legislative Committee at the 81st General Convention this past summer. Prior to this General convention she has attended the last four General Conventions as a visitor or exhibitor and has testified in hearings and walked resolutions through the legislative process. Gwen's bucket list wish is to some day represent her diocese by sitting on the floor as a Deputy at General Convention.
