BASICS OF CONVENTION RESOLUTIONS



Three Types of Resolutions:

- 1. General Business procedural
- 2. Mission Ministry Policy
- 3. Courtesy
- Resolutions can be developed by anyone but must be presented by delegate(s).
 - O Preferable to have more than one sponsor or congregation/entity shows support
- What does it mean for a resolution to be "in good order"?
 - O Review by Resolutions Committee and possibly Chancellor
- If there are budgetary implications, address that in your resolution.
- If you are referencing a specific outside document, make that info available for delegates to read.
 - O You can't ask them to endorse something they haven't read.

HOW TO WRITE A RESOLUTION



RESOLVED that...

- X WHAT will be done?
- X By WHOM?
- X With what RESOURCES?
- X HOW?
- X By WHEN?
- X Will be OVERSEEN BY or REPORTED TO whom?
- X WHY belongs in the EXPLANATION

2025 Resolutions to Convention





HISTORICAL EXAMPLE 2018-CO37 CALL TO **RESPOND TO OPIOID EPIDEMIC**



- Resolution originated in the Diocese of Maine in 2017/18
- Presented to Province I Synod (April 18) and endorsed by all
- Submitted to wider church selectively in May and June to build support
- Voted unanimously in committee
- Voted unanimously without debate at GC (July 2018)

RESOLUTIONS: RECEIVING FEEDBACK

- Identify possible objections while you draft.
- The first time you present your resolution will be at one of the online pre-convention meetings.
 - Tuesday, Oct. 14, 7 8:30 p.m.
 - Thursday, Oct. 16, 5:30 7 p.m.
- Friendly amendments and clarifications may be suggested.
- Be prepared to respond to those you could not use.
- Thank those whose suggestions were incorporated.
- At convention it's possible an amendment will be offered.
