# MAINE EPISCOPAL PUBLIC POLICY NETWORK REPORT TO DIOCESAN CONVENTION

(UPDATED September 16, 2025)

It's hard to categorize the first session of the 132nd legislature. To be sure, faith-based advocates were very effective on many levels (transgender rights) and unsuccessful on others (gun safety). Our partnership and commitment to the **Maine Council of Churches** remain strong, and my co-leadership of the <u>Public Policy Committee</u> has helped keep the group focused on issues where we can make a difference. The <u>Moral Agenda</u>, which guides our decision-making process, remains the foundation of our work.

Late in February, as the new legislature was getting underway, a legislator from Auburn created a national incident by posting the image of a transgender student athlete. I'm not going to relitigate that here, but include the reference as it set the tone for the whole session.

Coincidentally, a bill was submitted earlier in the process, before the social media posting, LD 537 - An Act to Prohibit the Doxing of a Minor and to Authorize a Related Civil Action. The Council testified in support of this bill, as did many other faith-based advocates. Last week, the House and Senate passed this bill.

This report is a summary of the legislative session grouped by category. The designations behind each bill are: **DEFEATED** or **PASSED** (a legislative victory), **LOST** (a defeat), and **CARRY OVER**, meaning it will be heard in the second session in January 2026.
