Resolution #8 – Establishing A Walking Together Diocesan Ministry

Resolution Title: Establishing A Walking Together Diocesan Ministry

- 1 RESOLVED that the 206th Convention of the Episcopal Diocese of Maine (EDOM) requests that
- 2 the Bishop's office establish a diocesan ministry, "Walking Together: A Faithful Response to
- 3 Those Made Vulnerable in Uncertain Times," dedicated to walking with immigrants, LGBTQ+
- 4 siblings, and others; and be it further
- 5 RESOLVED that this ministry will be grounded in the call of the prophet Micah, "to act justly, to
- 6 love mercy, and to walk humbly with your God" (Micah 6:8), and will carry out its mission
- 7 through prayer, relationship building, advocacy, education, and service; and be it further
- 8 RESOLVED that the 206th EDOM Convention encourage its congregations to participate in
- 9 Walking Together by engaging in intentional prayer, fostering relationships with immigrant and
- 10 LGBTQ+ communities, advocating for justice, providing educational opportunities, and offering
- 11 tangible acts of service; and be it further
- 12 RESOLVED that diocesan leadership support this ministry by providing resources, naming a
- 13 coordinator, and fostering partnerships with community organizations; and be it further
- 14 RESOLVED that progress on the work of Walking Together be reported annually to Diocesan
- 15 Convention, with recommendations for growth and continued faithfulness in ministry.

Brief Explanation:

The ministry of "Walking Together: A Faithful Response to Those Made Vulnerable in Uncertain Times" arises from our baptismal covenant to seek and serve Christ in all persons, and to strive for justice and peace among all people.

We recognize that immigrants, LGBTQ+ siblings, and others who are vulnerable often live with fear, uncertainty, and discrimination. As followers of Jesus, we are called to walk not alone but together, heeding the words of the African proverb: "If you want to walk fast, walk alone. If you want to walk far, walk with others."

The prophet Micah reminds us of God's expectation: "to act justly, to love mercy, and to walk humbly with your God" (Micah 6:8). Walking Together embodies this call by grounding its work in:

Prayer: holding one another before God, and shaping worship that affirms the dignity and gifts of immigrants and LGBTQ+ communities.

Relationship Building: fostering bonds of trust and solidarity with immigrant and LGBTQ+ neighbors, as well as with congregations and community partners.

Advocacy: speaking with and alongside marginalized communities to uphold their dignity in the public square.

Education: equipping congregations with resources and learning opportunities that expand understanding and compassion.

Service: accompanying our neighbors with tangible acts of love, welcome, and support.

By establishing Walking Together as a diocesan ministry, the Episcopal Diocese of Maine proclaims our commitment to walk faithfully with those on the margins, to strengthen our witness of love and justice, and to build a community where no one is left to walk alone.
